- Article VI, Section 15 is amended by adding at the end thereof "Roll call 2. requirements and quorum confirmation requirements may be satisfied by written check in procedures conducted by the property management company. The Power Point presentation used at the prior annual meeting may be used as the minutes for that meeting".
